# Corporate Apologies

- **Aetna (2000)**-apologized for selling policies in the 1850's that reimbursed slave owners for financial losses when their slaves died. Aetna acknowledged that for several years, shortly after its founding in 1853, the company may have insured the lives of slaves. (New York Times)
- **Brown University (2000)** Rhode Island offered a formal apology for its role in slavery. Brown's endowment came from slave owners' wealth. (New York Times)



# Corporation Apologies

- **Wachovia Corp (2005)** revealed that one bank it acquired had put thousands of slaves to work on a railroad. **(CNN/Money)**
- **JP Morgan (2005)** apologized for the role that a subsidiary had played in using 10,000 slaves as collateral and accepting more than 1,000 slaves as payment when owners defaulted on loans. **(CNN/Money)**



# Corporate Apologies cont...

- **Hartford Courant Apologizes for slave trade ads.** (The Providence Journal 2000)





# Economics of Slavery

- In 2008 the American Humanist Association published an article which argued that if emancipated slaves had been allowed to possess and retain the profits of their labor, their descendants might now control a much larger share of American social and monetary wealth. Not only did the freedmen and women not receive a share of these profits, but they were stripped of the small amounts of compensation paid to some of them during Reconstruction.



## Economics cont...

- The wealth of the United States was greatly enhanced by the exploitation of Black slave labor. According to this view, reparations would be valuable primarily as a way of correcting modern economic imbalance. The US Department of Commerce has calculated that in modern US dollars, calculated for inflation and interest, slavery generated trillions of dollars for the US economy.



## Economy Cont..

- Slavery is fundamentally an economic phenomenon. Throughout history, slavery has existed where it has been economically worthwhile to those in power. The principal example in modern times is the U.S. South. **Nearly 4 million slaves with a market value of close to \$4 billion lived in the U.S. just before the Civil War.**



## Economy Cont....

- Masters enjoyed rates of return on slaves comparable to those on other assets; cotton consumers, insurance companies, and industrial enterprises benefited from slavery as well. Such valuable property required rules to protect it, and the institutional practices surrounding slavery display a sophistication that rivals modern-day law and business.

# Prayer/Praise Journeys!

- THE SRM Men began praying together in Jan '09 and we began seeing results; one of our main prayer journeys was held on December 20, 2009 at the Gwinnett County Historic Court House. We openly dethroned some of our target principalities and powers.
- On December 25<sup>th</sup> the front page of the local newspaper published Luke 2:11-14 in big bold letters!

# Documented Results

- **Gwinnett County Narcotics Division Seizures 2009:**
  1. 8,660 lbs of marijuana valued at \$39m
  2. 137 lbs of powder cocaine valued at \$6m
  3. 5 ounces of crack valued at \$14k
  4. 18 lbs of meth valued at \$839k
  5. 5,174 illegal prescription drugs valued at \$95k
  6. \$481k in cash

# Documented Results cont..

## Victims Unit Arrested 2009

1. 84 for prostitution
2. 31 for pimping
3. 44 for massage without a permit
4. 73 for keeping a house of prostitution

# Documented Results cont....

## Highway Interdiction Team for Drug Traffic

1. 5030 traffic stops
2. 3200 citations issued
3. 3,694 calls for service
4. 12 stolen vehicles recovered
5. 204 felony arrests
6. 234 misdemeanor arrests

# Other Results

- **Freaknik 2010** Draws Smaller Crowd; Police have reported no major problems with this year's event
- **2009 Arrest Black Mafia Family**-The last remaining suspect, Vernon Marcus Coleman, was arrested on July 17, 2009 in Atlanta. He was indicted in 2007 for possession with intent to distribute cocaine. To date all 150 indicted members of BMF have been arrested. However, the total number of BMF members exceeds well over 150; the federal government believes the 150 they have indicted and arrested account for the command and control structure as well as other key figures in the organization (distributors, stash house operators, transporters, etc). # Document Result Education

- 12 schools/principals asked us to come in to pray and host a bible study.
- Discipline reports decreased in one particular school by a rather large percentage.
- Gang activity at one of the schools has decreased
- In 2009 all of the participating schools made Adequate Yearly Progress (AYP). (Title I schools)

# Education cont...

- Many of the schools received additional, unexpected funding to increase student achievement.
- Two of the principals participated in the development of the state flexibility contract, which is a part of restructuring the **national educational reform movement**. The initial meeting was held at one of the schools where the team met to pray.
- Three of the schools were in the top 10% in the district.

# Education cont...

- Three of the principals have mentored aspiring leaders which resulted in additional income.
- The County school system received a national prestigious award.
- A national magazine recognized this school district in 2009 for outstanding achievement for at-risk students who were successful on the Advanced Placement or International Baccalaureate assessments. (APIB)
- Two children who were diagnosed with rare forms of cancer are now cancer free.

# Education cont....

- Dr. Battle is now a member of a local school governance committee. (the principals refer to her as their Apostle of Education)
- 2 schools were just awarded \$75,000 unexpected
- One County School system has 200 new openings for teachers because of the increase in population, while other counties are having to take furloughs and decreasing teachers.
- Late 2009 this School system was awarded \$3 million for growth.

- Celebrating: Free Prom because 100% of all students were accepted in 4 yr colleges and Universities. **CNN News March 2010**



# Government Results

- **Feb 2010 Associated Press writes:** Despite several failed attempts to get Georgia to apologize for slavery, State Rep. Al Williams (who our Managing Director for SRM contacted) says he is reviving the resolution this session because “It is still worth fighting for.”
- And many more!
- We do understand that it has been the prayers of many people to help cause these results and we are thankful that God has chosen us to continue advancing HIS kingdom in this area.
